ALDERMAN CAMPER ASKED ABOUT THE MONEY FOR MAIN STREET AND CITY RECORDER CHRISTIAN ANGLIN CONFIRMED IT IS BUDGETED.

MAYOR GRACE UPDATED ON THE WATER TANK PROJECT BIDS. 5 BIDS WERE TURNED IN. CURRENS CONSTRUCTION GOT THE BID. VICE MAYOR TAYLOR LET ALDERMAN WILLIAMS KNOW THIS IS STRICTLY INTERIOR WORK THAT WILL BE DONE.

MAYOR GRACE ASKED ROBERT KELLEY TO UPDATE ON THE SEWER PROJECT. IT IS SET TO BEGIN MID OCTOBER DUE TO MATERIAL DELAYS.

THERE BEING NO FURTHER BUSINESS TO DISCUSS, THE MOTION WAS DULY MADE AND SECONDED TO ADJOURN. THEREFORE, MAYOR GRACE DECLARED THE MEETING ADJOURNED.
